### 2. SUPERINTENDENT'S REPORT

Mr. Guensler reported that he attended the NAFIS Conference in Washington D.C. in September. He said that the conference gave him a lot of information. He did find that the W.S.D. 8002 Impact Aid will be funded at four cents on the dollar. This is because of the "hold harmless" agreement that many districts have with Impact Aid. It lowers the amount of reimbursement for districts that have recently begun applying.

The process for the possible sale of the portables and A Street to the City of Wheatland is moving along. The actual property lines have been verified and the appraisal should be finalized in the next couple of weeks. The City attorney is working on recordings of the properties that were approved by the W.S.D. Board and the City Council years ago.

We came to an agreement with the Wheatland High School District regarding the revisions on the Impact Aid Table 9. They will pay us \$500 a year for the work that we did and \$500 a year for the future work on Table 9. It was a compromise on our part to continue to build the relationship with them. They will be paying us for the surplused items that they want from the old Wheatland Elem.

Mr. Guensler stated that he met with the two ladies that are trying to organize the library and is asking to use the District facilities. Mr. Guensler recommended that we hold off on this decision until we know what the new grounds will look like after the exchange of property with the City. He said that it is premature to have them move only to find out that the plans (re-fencing) with the City have significantly impacted the area. Nikki Crabb stated that she wants a legal opinion from an attorney on the A.D.A. Mr. Guensler stated that as it moves closer he will get a legal opinion and everything would have to be approved by the Board. There would be at no liability to the District.

Mr. Guensler reported that he was invited and attended the Civic Leader Tour through Beale Air Force Base. He said it was an amazing experience.
