#### 2.1 SUPERINTENDENT'S REPORT

Mr. Guensler passed out a draft of the 2011/2012 school calendar. Mr. Guensler explained that the school districts in Yuba County (except Camptonville) are looking to adopt this calendar. Mr. Guensler will bring the calendar back to Board in March for approval.

Mr. Guensler shared a chart that shows what the House is planning for Impact Aid funding. Mr. Guensler stated that everyone can expect a drop in payments largely due to the fact that while the funding levels would remain the same, the cost of the program will continue to rise.

Mr. Guensler reported that the District plans to replace the "all call" system. The new system, School House Messenger, will call, translate and call multiple numbers. It can be programmed by a computer vs someone actually recording a message. The cost of the system is equal to the current

one that we use. This system can be tied to school lunch charges and will make calls to parents owing money.

Effective March 1<sup>st</sup> the District will be doing away with time clocks. The new forms will be out and the administrators and classified managers will go over the process with staff.

Mr. Guensler reported that the Board will be discussing on offer that the City of Wheatland has made on the A street property in closed session.

2.3 Mr. Guensler reviewed the current district enrollment with the Board. The projected enrollment was 1146. The current District enrollment is at 1260.

#### 3. COMMUNICATION FROM THE PUBLIC

Cathy Bradshaw addressed the Board regarding an update on the plans for a Community Library. Mr. Guensler stated that he was contacted that at tonight's meeting that the Community Library would be discussed. He stated that the Board agreed that we would not be looking at this again until after the purchase of the A Street property was final and that we knew for sure what their plans are. Mr. Guensler said that he contacted our liability insurance regarding the placement of a Community Library on District property. Our liability would be great and we would be the subject of a lawsuit if something were to happen. Mr. Guensler stated that meeting the ADA compliance issues is also a factor. The bathroom that would be available to them is not ADA compliant. The insurance company expressed concerns that the portable would be able to handle the weight of shelving and books. They advised the District to have a structural engineer inspect the portable if we were to proceed. Based on this information, Mr. Guensler said that he does not believe it would be in the Districts interest to place a Community Library in any of our buildings or on any of our sites.

Dean Webb asked that the Board consider passing a resolution that would oppose the proposed expansion of the "dump" site in Wheatland. Mr. Webb stated that if this proposal passes, trash will brought in my train from San Francisco and beyond. Mr. Webb will bring additional information to the March board meeting for a discussion and possible action item.
