### 2. REPORTS AND COMMUNICATION

**2.1** Superintendent Update

Superintendent Guensler gave an update on the solar projects. He said that we are waiting for word from PG&E on connection dates. The ADA work at Wheatland Elementary should be completed in the next couple weeks. The parking lots have been opened for the staff.

Mr. Guensler reported that the E-Waste event went very well. Nick Steenberg did a great job with organizing it. He thanked the volunteers from Beale AFB, Nichole Steenberg and Jim Evans for their help. He also thanked his wife for her help.

Mr. Guensler stated that a K/1 position at Wheatland Elementary closed today. Interviews will take place on December 4<sup>th</sup>. We are planning to get the teacher on board before Winter break and have the students move over the day we return from break.

Superintendent Guensler reported out on the response to an email that he received.

- How much money have we spent on the solar project to date? \$319,000. \$274,000 was the down payment and we have spent \$11,500 on our own Project Managers. \$34,600 has been spent on inspections that are required by the State.
- What is the cost of the fencing project at Wheatland Elementary School? The project cost is \$21,800. We spent \$7300 on the steel and \$14,500 on the construction and installation of the fencing.
- Does the District have cameras on all buses?
   Yes. All of our buses now have camera, but the systems vary based on when they were purchased.
- What are the dates that the District will be closed over the holidays? The District is closed Wednesday through Friday of next week for Thanksgiving break. During Winter break, the District will be closed from December 23<sup>rd</sup> through January 3<sup>rd</sup>. We will be open the third week, which is January 6<sup>th</sup> to January 10<sup>th</sup>.

Superintendent Guensler reported that the numbers for Winter Break Camp are very low at this time. He stated that the District offered Winter Break Camp because of the three week Winter break. He said that the District will offer the Winter Break Camp. He said that if we do not have more students enroll, that we will not offer it again next year.

CBSA contacted Superintendent Guensler to offer a board presentation on the perks of becoming a member of CBSA. Mr. Guensler asked the Board if there is an interest in the CSBA presentation. After a short discussion, the Board decided to decline the offer at this time.
