#### 2. REPORTS AND COMMUNICATION

**2.1** Superintendent's Report

The Impact Aid day for our District will be Tuesday-October1st. This year the District will be using both pupil/parent survey cards and Aeries to verify student data.

The District depends on the Impact Aid funding, and we need to be sure that all bases are covered in case we are audited. We have sent information to Col Green regarding the documents that we will need for the Table 9 reports W.S.D. and W.H.S.

The U.S. Department of Education has again changed regulations and requirements for the Impact Aid 8002 application. We are currently working on those revisions. Bruce Stottlemeyer, the Yuba County Assessor is always cooperative and helpful. We work closely with him to complete the 8002 applications.

Superintendent Guensler asked the Board to mark their calendars for a Special Board meeting on November 1<sup>st</sup> (via phone). Mr. Guensler stated that he will be in Sacramento at a settlement meeting regarding the Bear River lawsuit, and he will need to contact the board if a reasonable offer is made.

Mr. Guensler stated that phase 1 of the fencing at Wheatland Elementary is complete and looks great. Phase 2 will begin soon.

The Bear River Solar Project has started. Wheatland Elementary Solar Project will begin either tomorrow or early next week. The crew will be moving back and forth based on needs and scheduled inspections.

Mr. Guensler reported that the "Breakfast For All" has proven to be very successful. The free breakfast program for all students in the District is growing in popularity every week. It is good to see that all students have the opportunity to start the day with a good breakfast at no cost to their family.

## 2.2 Enrollment

We have a total of 1255 students in or TK through 8<sup>th</sup> grade classes. This is 6 more than this time last year. We have 4 more students in the preschool than we had last year giving us a total of 1368 total students. Our class sizes are good but we are keeping an eye on the TK and Kdg classes at both sites, as they are very full. We have closed interdistrict transfers at TK, KDG and 6<sup>th</sup> Grade. Overall, classes look good and the enrollment is better than we expected
