2.1 Superintendent Update – Craig Guensler

Superintendent Guensler reported that the Wheatland School District had huge attendance issues today. We had 182 students not attend school today at Bear River due to the forecasted storm. Our normal absences at Bear River range between 15 and 20 students. At Wheatland Elementary School we had 54 students out today and their normal absentee rate is around 10. Lone Tree School was closed today. Mr. Guensler stated that he has had discussions with the base commanders today and they have not had any storm related problems, so all schools in the District will be open tomorrow. He said that there are a few options regarding the loss of attendance for one day. The first is to make up the day. The second is to apply for a waiver. If we are granted the waiver we are good to go and no make-up needs to take place. The third option is to adjust our calendar for all schools to 179 days. He said that he will discuss these options in detail with the Board at a later time.

Superintendent Guensler stated that he and Business Services attended a CMP Board meeting regarding the renewal of the contract with Business Services. CMP will be meeting soon to discuss this and to make a decision.

We have a number of areas on the new asphalt project that are in need of repair. We will be fixing these areas, but not likely until Spring Break or Summer Break. We need the weather to cooperate in order to fix the problem areas.

Mr. Guensler reminded the Board that he has set up a workshop/training for Wednesday, January 14, 2015 at 5:30PM. He said it will last about 3 hours. We also have a Board meeting on January 15th.
