2. REPORTS AND COMMUNICATION

2.1 Superintendent Update – Craig Guensler

Superintendent Guensler reported that the District has been asked to assist a group of parents with a "suicide prevention mud run". Three families from Wheatland each lost a son to suicide. Since then they have been putting on a mud run to bring attention to this rising problem and to raise funds for prevention services. The mud run will be held in Lincoln this year. There is no parking available, so we will be transporting folks to and from the mud run. Our bus drivers have volunteered their day to do this for free. The cost of the diesel will be covered by Brian Amsbaugh and Mr. Guensler (Nicole Crabb said would like to contribute too). Our preschool teacher, Kelley Waidmann is part of the organizing group for this function. Mr. Guensler said that he applauds all of the bus drivers, Kelley Waidmann, Nikki Crabb and Brian Amsbaugh for their donation of time and money.

The staff at Lone Tree has found 8 rattlesnakes on campus since school started. Most have been on the preschool playground. Mr. Guensler said that they have taken many measure to help protect the area and keep it safe for students and staff.

An assembly for "Rachel's Challenge" is scheduled for the 6th -8th grade students at Bear River in October. We will then pick some specific students to be trained in Rachel's Challenge. We are excited to get this going. Our plan is to start with the middle school and if all goes well, we will move to the other grad levels in the future.

Mr. Guensler stated that there was an intruder last Saturday Night and again this week at Bear River. With the help of the Wheatland PD and the parent, we have caught the student. He was suspended and cited by the police. We will be installing better cameras at both Bear River and Wheatland Elementary.

Mr. Guensler reported that he has a meeting scheduled next week with the potential contractors for redoing both the Wheatland Elementary School back parking lot and playground.

We have begun the process of changing who is responsible for specific duties in the food service department. So far things are going well and everyone is working hard to make this transition run smoothly.

We are putting together a technology training room. It will be a state of the art room and will benefit our staff with the implementation of Common Core. We are using Common Core funding to pay for this room. It will be here at the District Office. We are looking forward to this amazing space.
