2. REPORTS AND COMMUNICATION

Superintendent Update – Craig Guensler 2.1

> Superintendent Guensler reported that he, Angela Gouker, and Jim Evans attended a very eye opening conference today regarding Sexual Exploitation of Children. Many people believe that this is something that happens in 3rd world countries, but unfortunately the worst offender is the United States and the wort offending state is California. Mr. Guensler stated that this is something that he is going to try to organize for our return to school training. We need to learn how to recognize this with our own students.

> Mr. Guensler said that at the suggestion from a couple of Board Members, we have included Wheatland Elem and Lone Tree School to attend the summer Reni Conference. The cost is approximately \$10,000 and is covered by Title 2 funds, which must be spent on staff development anyways.

PERS –Classified Retirement. The percent that the District has to pay is going up from 11.847% to 13.888%. This is an added cost to the District.

Mr. Guensler thanked Northrup Gromman for sponsoring a trip to Summer Camp for one of our teachers and a student. The teacher and the student have been selected.

There will be some BAFB gate closures at the beginning of May. Mr. Guensler said that hopefully our busses will be accommodated, like last year. We will make alternate plans when necessary.

The Wheatland Relay For life is going well. Current totals are over \$43,000. Mr. Guensler turned in another \$2000 check today, which will push it over \$45,000.

Summer Camp is fully staffed and we have enrolled a lot of students. It will be another fantastic experience for our students.

Superintendent Guensler reminded the Board that we have a larger than average list of 8th grade students that are not meeting the grade requirements to participate in the 8th grade promotion ceremony. The school admin has contacted the families multiple times and have offered to help. They have made it clear what the students need to do to qualify to walk the stage. There are no surprises here. If the Board receives call, please know that every effort has been made to make the parents and students aware. They have been notified on multiple occasions.
