Mr. Guensler reported that he has been pushing to get another County Program on our site at Bear River for 4<sup>th</sup> -6<sup>th</sup> grade students. They currently have to go to Ella. Today he was told that we will indeed get that program. This will be good for our kids and save us on transportation costs.
