**2.1** Superintendent Update – Craig Guensler

Superintendent Guensler reported that Impact Aid Day for Surveys was October 18. Schools are busy collecting the forms

Wheatland Elem had their Harvest Festival yesterday. It was a huge success and the parents, students and staff were smiling ear to ear. They had fun games and some great prizes. Lone Tree has their Festival on Oct 27 from 4:00pm to 6:00pm.Mr. Guensler stated that he will not be able to attend this one.

Superintendent Guensler informed the Board that he attended a County Meeting on Monday where we discussed Special Education. Wheatland is seeing a larger than normal influx of Special needs students especially in the Preschool age group. This could cause the county to add another room next year if this continues.

There is a new student that has arrived at the Boys Home and requires Non Public School Placement. He is a high school student. We will be transporting him to Sacramento with our two students and will be billing the high school for half the costs. This helps them as they don't have to get a driver and a van and it helps us because we get to split our cost on transportation.

We have switched to the Red Dyed Diesel. This will save us about 42 cents a gallon in road taxes. School buses are exempt from these taxes. Most local Districts in Yuba and Sutter County are using Red Dye Diesel.

Halloween is on a Monday this year. We also happen to have a minimum day on Halloween which will be helpful given the students will likely have lots of sugar. We will make sure we have a presence on campuses just in case we have more clown scares which we do not expect but it is better to be proactive.

The High School Homecoming is next week. We have a couple of Board Members participating. We will loan two of our Gators to the high school for their festivities. We wish them luck with their parade and their game.

Mr. Guensler reported that we had a situation at one of our sites where a parent videotaped her child's class and then posted it on a public website. A parent of one of the students on the video was less than thrilled. We have made the parent aware that she does not have permission to post other students pictures or videos on public websites. We will be sending this message out again to all parents on the next flyer that goes home with students. We have signed permission to put students on our District websites but not on public sites.

Staff continues to donate towards Sue's sick leave. The family is overwhelmed with the support the District staff has shown them. There is also a meal train that was organized by the teachers at Bear River. We continue to hope for Sue to improve and start recovering so we can get her back where she belongs and that is with our students.
