- **2.1** Superintendent's Update
- ➤ We will have a significant budget shortfall in California which is projected to be \$22 billion. The Governor is making schools a priority in his budget.
- ➤ The COLA is expected to be 8.13% for next year. The final percentage will come out in April.
- ➤ The Transitional Kindergarten birthdate will extend to April for the 2023-24 school year. The following year, it will be from September 2 to June. This will put pressure on our preschools to drop down to 3 year olds.
- ➤ Universal free meals will continue. The May revise will tell us more.
- ➤ Met with Yuba County Office of Emergency Services. There are very few weather-related problems in Yuba County and there are no concerns for the next 10 days of inclement weather.

2.2 Enrollment

➤ We have 1354 students which is 13 more than last year and the same as last month. There are 113 preschoolers. That's 34 fewer than last year and 2 less than last month.
