2.1 Superintendent Update – Craig Guensler

- We completed a lot of the Audit work for the CTE Grants and sent it last month.
- The STRS Audit was also completed and we still haven't received the report since December.
- There's an insurance meeting tomorrow in Yuba City from 12:00 to 4:30, so Craig will be out of the office in the afternoon.
- Next Wednesday, Wheatland El will have their Reni Rally at 8:30 and 9:30; Lone Tree's will be on Thursday at 8:30 and 9:30; Bear River's is Friday at 8:30 and 12:00.
- We have 1 speech therapist, 3 teachers and 1 confidential employee who have notified the District they will be retiring. There may still be a couple of classified employees.
- We are expecting a significant storm tomorrow so hopefully our leaks will be minimal and the roads will be clear.
- Superintendent Guensler has a meeting with the county safety coordinator to get a plan written for a train derailment and evacuation plan.

We have 1345 students enrolled in TK – 8th which is 32 more than last year and 17 less than last month. There are 112 preschoolers at this time. That's 31 less than last year at this time and 1 less than last month.
