#### 2. REPORTS AND COMMUNICATION

- **2.1** Superintendent's Update Craig Guensler
- ➤ Superintendent Guensler reported this year has started off pretty well. We've had a few connectivity issues, but overall compared to other districts, we're doing really well. Again, he thanked everyone for their hard work over the summer to get things ready for this year.
- ➤ The District is providing lunch and breakfast which more than doubled now that it's free. The State has approved the free meals until December 31, 2020.
- ➤ We've done quite a bit towards connectivity, with outdoor WiFi at all schools including coverage here at the District Office. We have a smart-bus by the Camp Far West Lake exit on Spenceville Rd. The District has passed out 60 hot spots. One can work for multiple students. Chad has done a ton of work in this area.
- ➤ We're continuing to work with the County Health Department on the possibility of getting the waiver. The waiver is good for TK-5<sup>th</sup> grade and only allows us to return to a hybrid model.

### **2.2** Enrollment Report – Craig Guensler

- Enrollment is not spectacular. At the time of this report we had 1285 students which is 104 fewer than this time last year. 1182 students are participating in Distance Learning and 103 are in the Home Based Independent Study. Some changes are currently taking place with students moving from HbIS over to Distance Learning.
- There are 87 students enrolled in Preschool which is 47 less than last year.
- Nikki wonders if there is a plan to offer lunches through winter break. Craig will look into it and Ronna volunteered to help should we move forward with that.
- Nikki asked why students were moving from HbIS to Distance Learning when parents had signed a contract. Craig explained we are giving parents until tomorrow to decide if the program is a good fit for their family.
- Craig thanked the retirees for joining in the zoom, so we could honor them virtually. All 3 are long time employees of the Wheatland School District.
  - ❖ Martha Waltz spent 33 years teaching in the Wheatland School District. She worked for 22 years at Wheatland El in K & 2<sup>nd</sup>. She spent the next 11 years at Lone Tree School in 4<sup>th</sup> and 2<sup>nd</sup>.
  - ❖ Kristen Lavy worked in the Wheatland School District for 23.5 years. She spent all of those years at Wheatland Elementary School teaching mostly 1<sup>st</sup> and 2<sup>nd</sup>.
  - ❖ Cindy Hardee was employed 37 years in the Wheatland School District. Cindy began as a part time Para-Educator at Lone Tree before she moved into her dream job as a librarian. She has spent time at all 3 school sites. 7 years at Bear River; 13 at Lone Tree and 17 at Wheatland El.
- ➤ We wish each of them the very best. We hope they'll get lots of family time. Craig asked that they please stay in touch and offered virtual hugs to all three ladies.
